A SMALL MUSEUM HOUSING A SUBMARINE DESIGN IS LOCATED NEAR THE VESSEL. IN THE FISCAL YEAR ENDING SEPTEMBER 2016, APPROXIMATELY 35,000 PERSONS VISITED THE PARK.

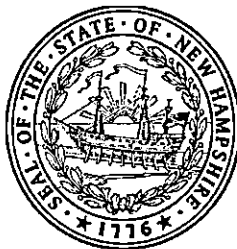
